WHAT HAS CHANGED

The 2024 update to the UK Competency and Values Framework (CVF) for police officers introduces several fundamental changes from the original framework established in 2016. Here's a breakdown of the most notable updates:

Greater Focus on Wellbeing and Inclusivity:

A significant addition to the 2024 framework is the increased focus on promoting well-being and inclusion within the police force. This includes creating supportive working environments, recognising the importance of mental health, and adopting diverse teams. While the 2016 framework touched on fairness and equality, the 2024 version emphasises these aspects more explicitly in everyday policing practices.

Technological Proficiency:

With the rapid growth of digital tools and online crime, the 2024 CVF strongly emphasises technological skills. Police officers are now expected to demonstrate competency with digital tools and better understand cyber-related issues. The 2016 version placed less importance on technology, as the policing landscape was less digitally focused.

Sustainability and Environmental Awareness:

For the first time, the 2024 framework incorporates sustainability as a guiding principle. Officers are encouraged to consider the environmental impact of their actions, reflecting broader societal concerns about environmental responsibility, which were not included in the original 2016 framework.

Refined Leadership and Accountability:

The new framework refines the concepts of leadership and accountability, encouraging individual responsibility and collective leadership at every level. Officers are now expected to work more collaboratively in solving problems, and there is a greater emphasis on personal accountability for decisions and actions, building on the principles outlined in the 2016 framework.

Enhanced Problem-Solving Abilities:

The 2024 CVF places additional importance on handling complex problem-solving. As crime becomes more sophisticated and interconnected, officers are expected to tackle these challenges with innovative and forward-thinking approaches, reflecting the need for more advanced problem-solving compared to the earlier framework.

Cultural Sensitivity and Ethics:

Reflecting changes in society, the 2024 update strengthens the expectation for officers to be more culturally aware and sensitive in their decision-making. This is more explicitly addressed than in the 2016 framework, aligning with modern values around diversity and ethical behaviour.

WHAT ARE THE 2024 CVF

Values

The 2024 Competency and Values Framework (CVF) for UK policing includes three core values reflecting the ethical principles required for modern policing. These values replace the four from the previous 2016 framework, designed to support public trust and accountability. Here are the updated 2024 CVF values:

Courage: This value emphasises moral and ethical courage. It expects officers to stand up for what is right, even in adversity. It requires officers to make ethical decisions under pressure and take actions that align with the law and public interest.

Public Service: Public Service remains one of the core values, highlighting police officers' commitment to serving the community and protecting it. Officers are expected to put the public's needs first, be responsive to the needs of individuals and communities, and act with dedication and professionalism.

Respect and Empathy: This value focuses on treating all individuals with dignity and respect while demonstrating empathy in interactions. It reflects the importance of fairness, inclusivity, and understanding diverse perspectives in policing duties and public engagements.

Competencies

The 2024 Competency and Values Framework (CVF) retains many competencies from the 2016 version. Still, it refines and re-words them to better align with the needs of modern policing and leadership. The refined competencies are as follows:

Emotionally Aware: Officers must demonstrate emotional intelligence by managing their own emotions and recognising those of others. The 2024 update emphasises using this awareness to maintain supportive, inclusive environments, particularly acknowledging neurodiversity and disability needs.

Take Ownership: This competency focuses on personal accountability, encouraging officers to take responsibility for their actions, decisions, and professional development. The 2024 refinement adds more clarity on ensuring tasks are followed through while acknowledging when to delegate effectively.

Work Collaboratively: Collaboration is a crucial focus, requiring officers to work well in teams within the police force and with external partners. The refinement encourages breaking down silos and emphasises the importance of teamwork in solving complex problems.

Support and Inspire: This competency highlights the need for officers to be role models who inspire confidence and leadership in others. Officers must lead by example, support their colleagues, and motivate their teams to achieve high standards.

Analyse Critically: Officers must critically assess situations, using data and evidence to inform decisions. The 2024 update has refined this competency to focus more on handling complex, cross-border issues like cybercrime and encourages creative problem-solving

Innovative and Open-Minded: The 2024 update emphasises adapting and embracing new ideas more. Officers must remain open to creative solutions, adapt to dynamic environments, and continuously learn from new experiences.

POLICE WRITTEN EXERCISE (2024 CVF)

The current format of the 2024 UK Police Officer Online Assessment Process for the Written Exercise involves taking on the role of a police constable and completing an urgent written task for your line manager. You will be provided with four pieces of information, such as emails, letters, or reports, which you will need to analyse and use to create your response.

During this exercise, you will be assessed against the following competencies and values:

Value

- Respect and Empathy

Competencies

- Analyse critically
- Support and Inspire
- Collaborate

You will have up to 120 minutes to complete this exercise. In the following sections below, we have created seven brand new exercises which you can use to prepare for the 2024 Police Officer Written Exercise. At the end of each exercise, we have provided points you could include in your response. **IMPORTANT NOTE!** The suggested answers included at the end of each exercise do not necessarily demonstrate the most efficient way of solving the issues highlighted. These are there as guidance only.

EXERCISE I RIVERBROOK YOUTH CENTRE

As a police constable, your Sergeant has asked you to address a community concern regarding ongoing disturbances around a newly opened youth centre in the town of Riverbrook. Several complaints have been received from local residents about noise, vandalism, and anti-social behaviour in the surrounding area. Meanwhile, staff at the youth centre report that these incidents involve a small group of individuals not affiliated with the centre, disrupting the young people attending legitimate activities. Your Sergeant has asked you to analyse the four pieces of information, which she has attached to the email and respond to the following four questions.

I. What are the key issues identified in the scenario and supporting documents?

2. How would you address the residents' concerns while supporting the youth centre's positive aspects?

3. What recommendations would you make to your Sergeant to relieve the issues while encouraging community collaboration?

4. How would you demonstrate respect and empathy in your approach to solving the problems?

SUPPORTING INFORMATION I: EMAIL FROM RESIDENT

"Dear Officer,

Since the youth centre opened two months ago, we have experienced almost nightly disturbances outside our homes. Loud music, shouting, and littering have become common occurrences, making the area feel unsafe. A group of teenagers has been gathering in the nearby park, and we have witnessed vandalism, such as graffiti on the park benches and broken streetlights. We urge the police to take action before things get worse.

SUPPORTING INFORMATION 2: REPORT FROM YOUTH CENTRE MANAGER

These individuals loiter outside during and after our hours of operation, causing disruptions and occasionally harassing our attendees. We have spoken to them multiple times, but the behaviour continues. We would appreciate any support the police can provide to ensure the safety of the centre and the surrounding area.

SUPPORTING INFORMATION 3: CCTV FOOTAGE

*Summary of CCTV footage from the area surrounding Riverbrook Youth Centre (Week of October 3-10):

October 3, 9:15 PM: A group of six teenagers is seen congregating near the park, playing loud music.

October 5, 8:45 PM: Three individuals are seen spray-painting graffiti on the walls near the youth centre.

October 8, 9:00 PM: Two individuals were involved in a physical altercation near the bus stop adjacent to the youth centre. No serious injuries were reported.

October 10, 7:30 PM: Two individuals are seen harassing a group of younger teenagers outside the youth centre entrance, with no police intervention.*

SUPPORTING INFORMATION 4: RESIDENT PETITION

We, the undersigned residents of Riverbrook, request immediate police action to address the rising level of noise, anti-social behaviour, and vandalism associated with the youth centre. While we recognise the importance of such a facility for the youth, we believe that more needs to be done to ensure that it does not negatively impact the quality of life for residents. We hope the police can respond positively and take appropriate action to curb this behaviour.

SUGGESTED POINTS YOU COULD HAVE INCLUDED: EX I

I. What are the key issues identified in the scenario and supporting documents?

- Noise and disturbance: Residents experience regular disturbances, including loud music, shouting, and littering, mainly during the evenings.

- Vandalism: Reports of graffiti on park benches and streetlight damage indicate ongoing issues with vandalism in the area.

- Harassment and antisocial behaviour: The youth centre staff have reported that individuals loitering outside the centre cause disruptions and sometimes harass legitimate attendees.

- Lack of association with the youth centre: The troublemakers are not participants in the youth centre's programs, which suggests the issue may stem from the nearby park rather than the centre itself.

- Community safety concerns: As the petition shows, residents feel unsafe and request police intervention to maintain order in the neighbourhood.

2. How would you address the residents' concerns while supporting the youth centre's positive aspects?

- Increased patrols: To deter antisocial behaviour, you could propose increasing police visibility through regular evening patrols around the youth centre and the parking area.

- Community liaison: Organise a community meeting to address concerns and create an open dialogue between residents, the police, and youth centre staff. This will adopt understanding and allow for joint problem-solving.

- Engaging with youth: Collaborate with the youth centre to offer programs targeting the disruptive group, encouraging them to join constructive activities and reduce negative behaviours.

- Clear communication: Keep residents informed about the steps being taken by the police and youth centre to address the issues, ensuring transparency and building trust within the community.

- Youth centre support: Acknowledge the youth centre's positive role in providing a safe space for young people and work with them to maintain its success while addressing external issues.

3. What recommendations would you make to your Sergeant to relieve the issues while encouraging community collaboration?

- Targeted patrols: You could recommend deploying officers during peak disruption hours (evening and early night) around the park and youth centre to deter vandalism and antisocial behaviour.

- Community engagement strategy: Propose monthly or bimonthly community meetings with residents, youth centre representatives, and the police to discuss ongoing issues and solutions.

- Outreach programs: Suggest collaborating with the youth centre to develop outreach initiatives specifically for disruptive individuals, aiming to channel their energy into constructive activities like sports, arts, or educational workshops.

- Restorative justice initiatives: Implement programs where those responsible for vandalism participate in community service, such as cleaning the graffiti, repairing damages, and promoting accountability.

- Collaborative safety planning: Work with the local council, youth centre, and residents to develop a long-term safety plan for

the area that includes increased lighting, more public amenities, and better security infrastructure.

4. How would you demonstrate respect and empathy in your approach to solving the problems?

- Listening to concerns: Show empathy by actively listening to the concerns of both residents and youth centre staff, validating their experiences and ensuring that their voices are heard.

- Engaging with the youth: Approach the disruptive individuals with understanding, recognising that they may lack productive outlets for their energy and providing opportunities for involvement in positive activities.

- Non-confrontational policing: Encourage officers to engage with the individuals respectfully and non-confrontationally, focusing on building trust and cooperation rather than purely enforcement.

- Equal treatment for all: Emphasise fairness and impartiality in handling the situation, ensuring that all community members, including the disruptive youth, are treated with respect and dignity.

- Transparency and communication: Keep the community informed about the steps to address the issues, providing updates in a clear and empathetic manner to build trust and reassure residents.

EXERCISE 2: TROUBLE AT ELMWOOD PLAZA

You are a police constable assigned to Westbourne, where a new public square, Elmwood Plaza, was recently opened. While the square has become a popular gathering place for families and local businesses, anti-social behaviour has also increased during the evening hours. Residents report instances of street racing, loud music, and occasional confrontations among groups of young people. Local business owners have raised concerns about the disturbances affecting their evening sales, particularly in outdoor cafes and restaurants.

Your Sergeant has asked you to compile a written report analysing the situation. Your report should address the complaints of local businesses and residents while considering the potential benefits the plaza provides for community engagement. Additionally, it would help if you proposed a plan to reduce anti-social behaviour without discouraging legitimate use of the plaza.

Your sergeant has also tasked you with preparing responses to the following four questions, which they will need to present to the community:

I. What are the key issues identified in the scenario and supporting information?

2. How would you address the concerns of the local residents and business owners while acknowledging Elmwood Plaza's positive aspects?

3. Based on the graph data, what does the community survey reveal about the general sentiment toward Elmwood Plaza, and how would this influence your recommendations?

SUPPORTING INFORMATION 1: EMAIL FROM BUSINESS OWNER

"Dear Officer,

Since the opening of Elmwood Plaza, my restaurant has enjoyed increased foot traffic during the day. However, in the evenings, we see a significant drop in trade due to the noise and disturbances caused by groups of teenagers gathering in the square. Customers have complained about loud music and shouting, and on several occasions, we've seen street racing on the nearby roads. These issues seem to get worse after 8 PM. We're worried that if this continues, we'll lose a lot of evening business. We need the police to address this before it drives customers away.

SUPPORTING INFORMATION 2: INCIDENT REPORT FROM PATROL OFFICER

*"Incident Log (October 10, 2024):

19:45 – Observed approximately 12 individuals playing loud music near the fountain in Elmwood Plaza.

20:10 – Received complaints from nearby restaurant owners about disruption.

20:30 – Witnessed two cars engaging in street racing on Elmwood Avenue adjacent to the plaza. Issued warnings to drivers, but no arrests were made.

21:15 – Minor confrontation between two groups near the plaza's bus stop, quickly dispersed by the police presence."*

SUPPORTING INFORMATION 3: COMMUNITY SURVEY

The following table shows data from a recent survey of Westbourne residents, capturing opinions on Elmwood Plaza's impact on the community. The survey was conducted over the last two months:

SUPPORTING INFORMATION 4: STATEMENT FROM LOCAL YOUTH ORGANISATION WORKER

"We have noticed that many young people involved in the evening disturbances at Elmwood Plaza are separate from any formal community activities. Some have told us they gather there because there are limited alternative recreational spaces for older teenagers. Providing more structured activities and a space for this age group could help reduce some problems. We are willing to work with the police and the local council to create more opportunities for youth engagement, especially during evening hours."

SUGGESTED POINTS YOU COULD HAVE INCLUDED: EX2

I. What are the key issues identified in the scenario and supporting information?

- Noise and disturbances: Loud music, shouting, and general disorder disrupt the evening atmosphere around Elmwood Plaza, negatively affecting local businesses and residents.

- Street racing: Multiple reports have been made of street racing, which endangers public safety and contributes to residents' safety concerns.

- Impact on businesses: Due to the disturbances, local businesses, particularly outdoor cafes and restaurants, are experiencing declining evening customers.

- Survey data: The community survey reveals mixed feelings about Elmwood Plaza, with 60% of respondents noting evening noise as a significant issue and 55% expressing safety concerns after dark.

- Lack of recreational options for youth: The note from the youth organisation suggests that the lack of alternative recreational spaces contributes to the gathering of young people in the plaza.

2. How would you address the concerns of the residents and business owners while acknowledging Elmwood Plaza's positive aspects?

- Increased evening patrols: To deter antisocial behaviour and street racing, suggest scheduling regular police patrols in the area during peak disturbance hours (after 7 PM).

- Noise control: To create a more peaceful environment for residents and businesses, propose stricter enforcement of local noise ordinances, especially in the evening.

- Engagement with youth: Collaborate with local community leaders and youth organisations to offer alternative activities or designated spaces for young people currently gathering in the plaza to avoid unnecessarily criminalising them.

- Encourage positive use: Acknowledge the plaza's success in promoting daily community engagement. Work with local businesses to develop evening events or family-friendly activities to maintain positive momentum and reduce the presence of disruptive groups.

- Targeted interventions: Consider using the CCTV around the plaza to monitor problematic areas and identify recurring offenders for more targeted intervention.

3. Based on the graph data, what does the community survey reveal about the general sentiment toward Elmwood Plaza, and how would this influence your recommendations?

- Positive sentiment: Most respondents (65%) appreciate the increased community engagement provided by the plaza, showing that it serves a valuable role during the day.

- Business impact: 58% of respondents feel the plaza has positively impacted local businesses, particularly during the day.

- Concerns about noise and safety: 60% of respondents highlight noise as a problem in the evening, and 55% express safety concerns after 8 PM. This suggests that while the plaza is well-received, significant evening-specific issues need to be addressed.

- Recommendations: These insights suggest that any police action should mitigate evening disturbances while maintaining the plaza's role as a community hub during the day. Increased patrols, noise control measures, and engagement with young people are crucial to addressing these concerns

4. What strategies would you recommend to reduce antisocial behaviour without discouraging the legitimate use of Elmwood Plaza?

- Designated quiet hours: Implement a "quiet hours" policy starting at 8 PM, with clear signage and enforcement, to curb loud music and disturbances.

- Youth engagement programs: Work with the local youth organisation to develop evening programs or events that attract young people and offer an alternative to disruptive behaviour.

- CCTV monitoring and quick response: Install or enhance CCTV monitoring in the plaza to allow faster responses to incidents like street racing and confrontations. Regular monitoring can also help gather evidence for long-term solutions.

- Increased presence of community officers: Deploy community liaison officers in the evenings to engage with the groups of young people, offering guidance and establishing trust rather than immediately resorting to enforcement.

- Collaboration with businesses: Encourage local businesses to host evening events or markets to attract more family-friendly crowds, diluting disruptive groups and providing positive alternatives for entertainment.

EXERCISE 3: RIVERSIDE AVENUE TRAFFIC CHAOS

You are a police constable assigned to the small town of Barkside, where Riverside Avenue's main commercial area has recently experienced increased traffic-related issues. During peak shopping hours, the town council has received multiple complaints about dangerous driving, speeding, and illegal parking. The area is home to several schools, businesses, and a popular park, Barkside Green, which attracts families, particularly on weekends.

Local residents have expressed concern for pedestrian safety, as there have been several near-miss incidents involving children crossing the road from Brookside Primary School to Riverside Avenue. The town council requests a plan to manage traffic and improve road safety, particularly for pedestrians. Your sergeant has asked you to investigate and provide a report with recommendations.

*Incident Report – Riverside Avenue (October 8, 2024):


08:15 – Observed traffic congestion near Brookside Primary School due to parents dropping off children. Two vehicles were parked illegally in the no-parking zone near the school gates.

15:45 – Witnessed a near-miss involving a child crossing the road. The driver was speeding and failed to stop at the crosswalk. No injury occurred, but the child was visibly shaken.

16:30 – Multiple vehicles were reported parked along the sidewalk near the shopping area on Riverside Avenue, obstructing pedestrian access.*

SUGGESTED POINTS YOU COULD HAVE INCLUDED: EX3

I. What are the key issues identified in the scenario and supporting information?

- Speeding: Vehicles regularly exceed safe speeds on Riverside Avenue, particularly during peak hours, as shown by the traffic monitoring data (averaging 38-42 mph).

- Illegal parking: There are multiple incidents of cars parking illegally near the school and shopping district, blocking pedestrian access and reducing visibility at crossings, leading to near-miss incidents.

- Pedestrian safety concerns: Families and children crossing the road, especially near the school and park, are at risk due to speeding and poor visibility caused by parked cars.

- Traffic congestion: The high volume of vehicles during drop-off and pick-up times creates dangerous conditions around the school and shopping district, mainly where crossings are located.

2. How would you address concerns raised by local residents and ensure pedestrian safety?

- Traffic calming measures: To slow down traffic, propose installing speed bumps or raised crossings near Brookside Primary School and the shopping district.

- Increased patrols and enforcement: Regular police patrols during peak hours are recommended to enforce speed limits and issue fines for illegal parking, particularly around the school.

- School crossing warden: To help children cross safely, suggest introducing or increasing the presence of crossing wardens near the school during drop-off and pick-up times.

- Clear signage and parking restrictions: Advocate for clearer "no parking" signs, painted curbs near the school and shopping district, and stricter enforcement of parking violations to ensure pedestrian visibility.

3. Based on the map and data, how would you propose improving traffic flow and safety around Riverside Avenue?

- Reposition crossings: Consider repositioning or adding a crosswalk closer to Brookside Primary School's entrance, where illegal parking often blocks visibility, as shown on the map.

- Traffic rerouting: Suggest rerouting from Willow Drive during school hours to reduce congestion on Riverside Avenue.

- Pedestrian-focused enhancements: Based on the map, install pedestrian-friendly infrastructure like wider sidewalks near Brookside Green and the shopping district to better separate foot traffic from roadways.

- Weekend traffic management: Since the data shows many vehicles on weekends, implement temporary road closures or pedestrian zones near Brookside Green on Saturdays and Sundays.

4. What strategies would you recommend to reduce traffic incidents while maintaining the positive use of the commercial area?

- Timed road closures: To create a safe, pedestrian-only zone near the park and shopping district, certain sections of Riverside Avenue should be closed to vehicles during peak pedestrian hours, particularly on weekends.



I. What are the key issues identified in the scenario and supporting information?

- A spate of burglaries: Ashgrove has seen a noticeable increase in burglaries, mainly targeting affluent areas. These incidents share a similar pattern of break-ins between 8:00 PM and 11:00 PM, with forced entry through rear doors and the theft of high-value items.

- Community safety concerns: Residents, such as Caroline Green, feel unsafe in their homes, especially after several incidents reported within proximity. Many are calling for increased police presence and security measures.

- Burglary hotspots: The map shows an apparent concentration of burglaries in specific affluent neighbourhoods, which indicates that the burglars may be systematically targeting these areas.

- Concentration in affluent areas: The map clearly shows that burglaries are concentrated in wealthy neighbourhoods like Elmwood Avenue, Birch Road, and Oak Lane, suggesting that the burglars are specifically targeting these areas for high-value items.

- Standard method of entry: Most incidents involve forced entry through rear doors, indicating a need for residents to reinforce these entry points with more robust locks or security features.

- Targeted time frame: The burglaries typically occur between 8:00 PM and 11:00 PM, suggesting that patrols and surveillance should be concentrated during these hours to increase the chance of catching offenders in the act.

- Recommendations: Based on these patterns, I recommend prioritising patrols in the identified burglary hotspots, encouraging residents to improve rear-entry security, and using the map data to set up temporary CCTV or surveillance in the areas most at risk.

- Enhanced security measures: Work with local stores or security companies to offer discounts on home security systems (e.g., cameras, door reinforcements) for residents in high-risk areas. The police could also offer free home security assessments.

- Surveillance and Technology: Propose installing temporary CCTV cameras in burglary-prone areas and increasing the use of ANPR (Automatic Number Plate Recognition) technology to track vehicles leaving the scene of reported burglaries.

- Community reporting platform: Create a dedicated online or phone app for residents to report suspicious activity and receive crime prevention tips. This would encourage real-time reporting and faster police response to any future incidents.

EXERCISE 5: MAPLE COURT MADNESS

- Noise and disturbances: A large majority of the complaints are about groups gathering in the communal areas (stairwells, car park) and causing noise disturbances late at night, affecting residents' quality of life.

- Vandalism: There have been several incidents of vandalism, particularly in the car park, where residents' cars have been damaged. This is contributing to a sense of insecurity among the residents.

- Suspected drug activity: Reports of the smell of cannabis and suspected drug use are further escalating residents' concerns about safety.

- Resident safety concerns: The survey shows that 72% of residents do not feel safe within their building, and Helen Murphy's email highlights the fear that some residents, especially the elderly, have about leaving their flats.

- Management Collaboration: The building management is willing to collaborate with the police, you could consider installing CCTV and seek increased police patrols to deter these activities.



EXERCISE 7: NORTHMINSTER NEAR-MISSES

You are a police constable assigned to investigate growing concerns regarding public safety on Northminster Bridge, which connects the Riverside District to the Eastside Commercial Area. The bridge, a vital route for vehicles and pedestrians, has seen a rise in incidents involving speeding vehicles, near-miss collisions with cyclists and pedestrians, and complaints about unsafe conditions for those on foot or bike.

Multiple reports of traffic accidents and near misses, especially during peak hours, are available. With vehicles, cyclists, and pedestrians sharing the bridge, the lack of safety infrastructure has led to hazardous conditions. The proximity of Riverside Primary School on the west side of the bridge and the heavy traffic leading into the commercial district has exacerbated the issue, with several incidents involving children and elderly pedestrians.

- Traffic safety concerns: The bridge is shared by pedestrians, cyclists, and vehicles, but the narrow pathways and lack of proper signage or separation between users have led to multiple near-miss incidents involving both pedestrians and cyclists.

- High traffic volume: The data shows heavy bridge usage by motor vehicles and non-vehicle traffic (pedestrians and cyclists), particularly during peak hours. With an average of 400-450 cars and significant numbers of pedestrians and cyclists, congestion contributes to safety risks.

- Lack of infrastructure: The map highlights that pedestrian and cyclist paths need to be more adequately sized for the amount of traffic, and there are no clear separation barriers between the different users. The limited crossings and lack of sufficient signage, especially near the school, are also significant concerns.

- Community unrest: The protest that blocked the bridge indicates that tensions are rising. Residents feel that their safety concerns are not being addressed, leading to disruptive actions.

2. How would you address the concerns raised by the residents and schools while considering the need to keep traffic moving efficiently?

- Traffic calming measures: Implement traffic calming measures, such as speed bumps or reduced speed limits on the bridge, to ensure that vehicles travel at a safer speed, particularly near crossings and entrances.

- Improved signage and crossings: I recommend installing better signage warning drivers about pedestrian and cyclist traffic and creating additional, clearly marked crossings near the school and at both ends of the bridge.

- Separate lanes for cyclists and pedestrians: To minimise the risk of accidents, advocate for the construction of dedicated, clearly separated lanes for cyclists and pedestrians on the bridge.

- Temporary traffic management: Suggest deploying temporary traffic officers during peak hours to manage vehicle and pedestrian traffic flow until long-term solutions can be implemented.

3. Based on the traffic data and incident reports, what longterm infrastructure improvements would you recommend to ensure safety for all users of Northminster Bridge?

- Widening of pedestrian and cyclist paths: The data shows that a significant number of pedestrians and cyclists use the bridge during peak hours. Widening the pathways to accommodate this traffic more safely should be a priority, reducing the likelihood of vehicles forcing cyclists or pedestrians into the road.

- Physical barriers: Install physical barriers or raised dividers between vehicle lanes and pedestrian/cyclist paths to prevent vehicles from encroaching on the non-vehicle traffic areas.

- Pedestrian and cyclist bridges: Explore the feasibility of building a separate pedestrian/cyclist bridge adjacent to the existing one to reduce congestion and improve safety. This would allow vehicle traffic to flow more freely while providing a safer crossing for nonvehicle traffic.

- Signal-controlled crossings: Install signal-controlled pedestrian crossings at the bridge's entrances and exits, particularly near the school and the commercial area, to ensure that pedestrians can cross safely during busy traffic periods.

4. How would you manage the tensions between the community and the authorities, given the protests and rising frustrations?

- Community engagement: Organize regular community meetings to update residents and business owners on the progress being made toward improving safety on the bridge. Listen to their concerns and provide clear, actionable plans to address them.

- Short-term solutions while long-term plans are developed: Offer temporary solutions, such as increased police presence during peak hours or the use of temporary barriers or signage to improve safety while infrastructure changes are being planned and implemented.

- Collaboration with local schools and businesses: Work closely with schools, particularly Riverside Primary, to develop safer routes for children walking to school, and coordinate with local businesses to ensure that any changes to traffic flow or pedestrian paths do not negatively impact their operations.

- Public awareness campaign: Launch a public awareness campaign to educate drivers, cyclists, and pedestrians about bridge safety and the importance of following traffic laws, especially during

peak hours. This could include leaflets, social media posts, and collaboration with local schools and businesses.

IMPORTANT NOTES

The suggested responses in this guide do not particularly demonstrate the most efficient solution to the issues in the scenarios. When undertaking these tests, you should approach them clearly and focus on the competencies and values you are being assessed upon in the exercises.
